Bleckmann GOH Shipping Requirements

All garments shipped on hangers to Bleckmann must be packed in GOH flat lock boxes. The garments should be laid in alternating direction, ensuring the hanger hook is securely fastened inside the lockbox, taking care not to overstuff the carton. The carton should be large enough to fit the garments while lying flat and not folded.
